ARTISAN APPLICATION

Thank you for exhibiting at Harbor Day at the Docks. This waterfront heritage festival is the first of its kind in the Ocean City area. Below are the criteria and information regarding the event. If you are interested in exhibiting your craft at the event, please fill out the application below. Your application will be presented to the committee for review and you will be notified if you are selected to exhibit. Exhibit space is limited, and artisans will be selected based on the nature of their craft (maritime-related artisans are preferred). Artisans are also asked to demonstrate the making of their craft (if possible) in their booth space.

- **Artisan spaces are \$150 (If you do not have a business license, you will be required to purchase a Peddler's License for an additional \$25. See attached application).**
- **All spaces are 10'x10' and will be under a large exhibitor tent. No pop-up tents will be necessary.**
- **All spaces include (1) 8' undraped table and 2 chairs. All additional display materials are the responsibility of the artist.**
- **No electricity will be available.**
- **Booth setup begins at 7 am on the day of the event (10/10). All booths must be setup and ready no later than 9:30 am.**
- **Exhibitors may begin breaking down their booths after the Blessing of the Harbor (beginning at 4pm). All booths must be packed up no later than 6 pm.**

Refund Policy: A full refund minus a \$25 administrative fee will be issued if the vendor cancels prior to September 4, 2009. After September 4th, no refunds will be issued for any reason. Rain date for the event is Sunday, October 11th.
